Location and Time:

The Loblolly Festival will be held in Downtown Laurel, Mississippi on Saturday, October 1, 2011. The Festival will open at 9 a.m. and end at 6 p.m.

Booth Space:

Each booth space will be 10'x12'. Electricity or water must be requested in advance via this application.

Entry & Deadline:

An accepted application is a commitment to show on the basis of acceptance. The acceptance letter will follow our receipt of the application and payment. No entries will be accepted after September 1, 2011. No refund will be made for cancellation after August 31, 2011.

Vendor Selection:

The Festival Committee reviews applications based on photographs and descriptions of your items. All items for sale will be reviewed and a letter will be sent if you are accepted. Vendor selection is at the discretion of the Festival Committee. If you sell items at the festival not listed on your application, you may be asked to take those items down or leave the show area.

Additional Terms and Conditions:

This is a rain or shine event. There is no rain date. No refunds will be given for any reason after August 31, 2011. All vendors must stay for the entire event. Vendors are responsible for all equipment used for their exhibits. If you have a canopy or awning, it must be secured by weights. The Loblolly Festival is not responsible for the loss or damage of any items. Each exhibit must be manned at all times during the festival hours. Each vendor is responsible for collecting Mississippi state sales tax (7%) as required by law. You will be provided a tax envelope and we will collect these envelopes 30 minutes before the event is over.

The undersigned does hereby and forever discharge Laurel Main Street of and from all manner of actions, suits, damages, claims and demands whatsoever in law or equity from any loss or damage to the undersigned's property or person while in possession, supervision or auspices of Laurel Main Street, its agent, representatives or employees.

By signing below, the Vendor indicates that Vendor has read and agrees to comply with all conditions printed within this application. Violation of these conditions or any violation of law will result in the forfeiture of Vendor's space and Vendor expressly agrees to waive any rights to recourse or to demand a refund to claim damages on such grounds.
